 $\underline{5.12.210~(E)}$  To qualify for issuance of such permit the applicant must not have been convicted of any felony or violation of the laws of any jurisdiction relating to the manufacture, sale or use of alcoholic beverages or controlled substances or of any sex crime or crime against children five years of the sentence for which, including probation or parole, has not been completed at the time of application for the permit.

A \$35.00 nonrefundable fee for each permit, (cash, credit card or money order) paid to the Covington Police Department. A background check will be done at this time.
