## **Pawn Shop Applicant**

## Dear Applicant:

In accordance with the provision of the City of Covington Ordinance, each person or entity desiring to operate or be an employee of a pawnshop within the city shall first make an application in person to the Covington Police department to obtain its own individual permit to carry on such activity.

No such permit shall be issued to a person who, within the five years next preceding the date of the application, has been convicted or pled guilty or entered a plea of nolo contendere to a crime constituting a felony, or involving moral turpitude, theft or fraudulent practices, or who has falsified, concealed or misrepresented any material portion of the application.

No pawnbroker shall allow any employee to work in a pawnshop unless the employee has been issued a current valid permit.

Complete the enclosed application for the additional pawnshop license and return it to this office with the following:

• A \$50.00 fee (cash, check or money order) paid to the Covington Police Department. A background check with be done at this time.
